

The earned interest yield presented above does not have any costs deducted. The investment management costs in prior years and this year continue to be approximately 6 basis points or 0.06%. The quarterly apportionment of earnings to participating funds will be made on a cash basis (as opposed to an accrual basis) for the first three quarters of the fiscal year. Earnings to participating funds will be annualized over the fiscal year based on a fund's cumulative average daily cash balance at each quarter end and fiscal year end. At fiscal year end (fourth quarter), the earnings of the Pool will be converted to an accrual basis for the fourth quarter earnings' allocation.


Financial Markets Commentary


On June 18, 2025, the Federal Open Market Committee (FOMC) unanimously left the federal funds rate unchanged at a range of 4.25% to 4.50%, citing continuous uncertainty from President Trump's tariff policy and risks to economic growth and the labor market. It was the fourth straight meeting of no change to the federal funds rate after a 1 percentage point decrease over final three meetings of 2024. The FOMC raised its year-end 2025 inflation forecast from 2.8% to 3.1%, while GDP growth was revised down from 1.7% to 1.4%.

Markets have stabilized since April 2, 2025, when President Trump announced sweeping tariffs on imports from over 50 countries, sending equity markets crashing. A week later, after steep losses in equities spread to the US bond market and the US dollar, the President reversed course and announced a 90-day pause. Equity markets have completely recovered to hit new highs, although the bond market and the US dollar remain under stress. The President has once again delayed the start of tariffs which were to take effect on July 9, 2025, to August 1, 2025, while threatening Japan and South Korea, two key trading partners, with a new 25% tariff. Markets have declined on the news.

Contrary to the FOMC's forecast for higher inflation and slower growth, the current figures still show a robust economy with modest inflation. The Federal Reserve's preferred inflation gauge, Personal Consumption Expenditures (PCE), rose from 2.2% to 2.3% year-over-year in May, while Core PCE (excluding volatile food and energy) rose from 2.6 to 2.7%. Inflation remains unexpectedly restrained given all the uncertainty surrounding tariff policy. The labor market readings for June also showed surprising resilience. Nonfarm payrolls rose 147,000 in June and revisions from the prior two months showed an additional increase of 16,000.

Based on the FOMC's current projections, we project the yield on the Pooled Investment Fund to decrease over the next few quarters.





Portfolio Management Strategy

During the past quarter, we continued to provide adequate liquidity to meet the cash flow needs of the Pooled Investment Fund participants. We are currently funding the cash flows for January 2026. We are purchasing five-year U. S. Treasury, U.S. Agency, and Washington Supranational securities on a monthly basis for the "CORE" portfolio, which is composed of all securities maturing beyond one year. This laddered structure stabilizes the yield over longer periods. Over the next quarter, our quarterly yield should range between 3.80% and 4.00%.
